- Shotwell, a daughter of Henry and Sarah Shotwell, and removed to St. Joseph County, Indiana (Rec.:9:32 & 36; Comp. Amer. Gen. v.3, p.454).
- (f) Benjamin' b. Feb. 23, 1748/9; d. in 1813. On Nov. 23, 1786, mar. at Rahway, Mary Shotwell, b. July 29, 1764; d. April 21, 1841, a daughter of Daniel and Deborah (Shotwell) Shotwell of Woodbridge. In his will, executed Sept. 5, 1813, and proved Feb. 8, 1815, Benjamin Thorn of Rahway remembered wife Mary, son John, and unnamed minor children, and appointed "cousin Isaac Vail" an executor. The inventory of the estate, dated Oct. 9, 1813, amounted to \$3,004.031/2 (Shotwell Gen., p.103 & NJA:42:424-25).

June 4, 1704; d. before Nov. 5, 1750, in Woodbridge, N. J., a son of James and Rebecca (Hallet) Jackson of Flushing. On April 12, 1730, Rebecca (Hallet) Jackson died, after bearing her husband twenty children; on June 3rd of that year, the old man was dealt with by the Flushing Meeting for "too hasty marriage with a second wife," and on May 6, 1731, disowned. James, Jr., mar. (2nd), about 1737, Mary——, and (3rd), by N. J. License dated May 26, 1749, Mary Fitz Randolph, as her fourth husband. She had mar. (1st), William' Thorne No. 68, a son of Joseph and Martha Joanna (Bowne) Thorne, and after his early death mar. (2nd) her cousin — Fitz Randolph. His exact identity has not been established but he was probably Joseph Fitz Randolph, a son of Samuel and Rebecca (Jones) Fitz Randolph, of Woodbridge, N. J. On March 16, 1744, as "Mary Fitzpatrick" [Spinster], she mar. (3rd), Marmaduke Horseman, then in his eighties (NJA:22:147 & 186). On the death of James Jackson Mary Fitz Randolph mar. (5th), Jacob Fitz Randolph, a brother of Joseph, her presumed second husband, and on July 18, 1764, was "disowned for marriage to her first cousin." (Fitz Randolph Gen., 1950, pp. 10, No. 41 & 20-21, No. 46). Both of the Thornes involved in this dark story died young. There are many Spoon Rivers in America. No record has been found of any children of James and Sarah (Thorne) Jackson (Col. Joseph Jackson, 1883, p.5 & Hinshaw, v.3, p.182).
- 5. Susannah<sup>2</sup> Thorne was born probably about 1645, and died presumably about 1696 in Hempstead. She married by New York license dated July 10, 1667, John Okeson, who was born in July of 1645, and died in 1696 in New York City, leaving two sons: John<sup>3</sup> and Daniel<sup>3</sup>, the latter of whom adopted the surname Kissam. This family is described in "John Okeson of Hempstead, Long Island, and Some of His Descendants" (Rec.:91:65-74).
